

**Agreement between Sao Chang College Tuensang
And
Krishi Vigyan Kendra, Tuensang**

This agreement is made on 30th day of Sept 2016 by and between

WHEREAS Sao Chang College, Tuensang is an Educational Institute established in 1973 and subsequently recognized as a Government College in the year 1983 under the Department of Higher Education, Government of Nagaland. The Institution (hereinafter referred to as SCC) is a premier secular College under Tuensang District catering to Undergraduate course in both Arts and Science Streams.

WHEREAS, Sao Chang College, headed by the Principal Dr. Imliwati Imchen, Vice Principal Shri. Longtichang Tzudir and teaching faculty of Assistants Professors and Associate Professors, shall be assisted by the Krishi Vigyan Kendra in imparting technical expertise both in theoretical as well as in practical to the students in conducting the Vocational Course in Floriculture (Diploma Course of 6 months duration), Sponsored and Funded under RUSA, Ministry of Human Resources Development, Government.

WHEREAS, Krishi Vigyan Kendra (hereinafter, referred as KVK) under India Council of Agricultural Research (ICAR) is an Agricultural Technology Application & Research Institute entrusted to test and refined technologies and disseminate the same to the farming community on the basis of location specific requirements. Krishi Vigyan Kendra, Tuensang: Nagaland was established in 2007 and the Kendra is untiringly working to fulfill these mandates for self sufficiency in agriculture and sustainable utilization of resources.

WHEREAS, the KVK, being Technology Application and extension centre having Scientists in different field under Senior Scientist and Head, Dr Keviletsu Khate shall henceforth provide technology and extension services; KVK, Tuensang shall provide technology support for up gradation of knowledge and skill of the students through diploma course in Floriculture under Vocationalization of Higher Education funded by RUSA, Ministry of Human Resource Development, Government of India, as long as the course is concern.

This agreement can be reversed as and when required.

Both the parties are sanctioned to have review and reflection concerning the implementation of the programme as and when the need arise, the parties can have joint meeting to discuss and evaluate the status and achievement of the programme. All reports concerning the status and progress of the programme to the funding agency (Ministry of Human Resource Development, Government of India/Directorate of Technical and Higher Education, Govt. of Nagaland) by the implementing Agency (Sao Chang College, Tuensang) shall be made known to the KVK, the second party in agreement, for re-strengthening the implementation process if necessary.

Termination of agreement:

The agreement can be terminated after the end of the programme/course.

Settlement of disputes:

Any dispute or differences or question arising at any time between the parties hereto arising out of or in connection with the two in relation to agreement shall be referred to and settled amicably between the parties.
