

# Memorandum of Understanding (MOU) Between Sao Chang College And Motor Pal Driving School

Purpose: This Memorandum of Understanding (MOU) sets forth the terms and conditions under which Sao Chang College and Motor Pal Driving School will cooperate to provide driving education to the students of the College.

**Duration:** This MOU shall be effective from June 2024 and shall remain in effect until terminated by either party in accordance with the terms set forth herein.

# Responsibilities of Sao Chang College:

**Provision of Grounds:** The College agrees to provide the Driving School access to its grounds to conduct driving classes. Both parties will mutually agree upon the specific area and schedule for the use of the ground.

# Responsibilities of Motor Pal Driving School:

Free Driving Classes: The Driving School agrees to offer free driving classes to a designated number of meritorious students from the College.

Qualified Instructors: The Driving School will provide qualified instructors to conduct the driving classes.

## Selection Criteria for Meritorious Students:

Academic Performance: Students will be selected based on their academic achievements as determined by the College.

Financial Need: Consideration will also be given to students who demonstrate financial need.

Other Criteria: Additional criteria may be established by mutual agreement between the College and the Driving School.

## General Terms:

Amendments: Any amendments to this MOU must be made in writing and signed by authorized representatives of both parties.

### **Dispute Resolution:**

Any disputes arising from this MOU shall be resolved through mutual consultation between the parties.

The College reserves the right to cancel the agreement at any point of time with one month notice.

The College should equip students with multiple options, which is why there is an urgent need to collaborate with various agencies so as to offer skill courses, vocational courses, value added courses

and so on.

Therefore, it is my earnest appeal to the leaders of Tuensang Village Chongpho Citizens to show your solidarity and cooperation in the larger vision of the College which, today, may seem like a tiny step that the College is taking, but which is designed for the betterment of the students and to rid the institution of mediocrity.
