MEMORANDUM OF UNDERSTANDING

THIS MEMORANDUM OF UNDERSTANDING (MOU) is entered on this 25 day of December, 2022, at Kohima, Nagaland.

### BETWEEN

Department of Higher & Technical Education, Government of Nagaland, having their office at Below New Secretariat; Thizama Road, Kohima-797001; Nagaland; represented by the Secretary, Government of Nagaland, Department of Higher & Technical Education, Government of Nagaland (hereinafter called "DHTE") (which expression shall unless repugnant to the context thereof shall mean and include its administrator, successor in office, representative, assigns) of the FIRST PARTY.

#### AND

SGBS UNNATI FOUNDATION (SUF) is a registered not for profit Company, registered U/S 25 of the Companies Act, 1956, having its registered office at No. 1, Temple Road, Sadananda Nagar, NGEF Layout, Bangalore – 560038 and represented by its authorized representative Director, Shri I. A. Padmanabhan alias Ramesh Swamy, (hereinafter called "Unnati") (which expression shall unless repugnant to the context





thereof shall mean and include its administrator, successor in office, representative, assigns) of the SECOND PARTY.

#### AND

Investment & Development Authority of Nagaland, having its administrative office at Capital Convention Center, opposite New Secretariat, Kohima, Nagaland- 797001, (hereinafter referred to as IDAN) represented by its representative Shri. Alemtemshi Jamir, CEO, IDAN, Nagaland which expression shall unless repugnant to the context or meaning thereof, be deemed to mean and include its administrator, successor in office, representative, assigns) of the THIRD PARTY.

**IDAN** is constituted by the Governor of Nagaland to facilitate creation of investment opportunities and to explore all possible funding/investment opportunities for infrastructure and socio-economic development of the Sate and is eligible to undertake CSR projects as implementing agency pursuant to applicable provisions of the Companies Act, 2013. The CSR registration number of IDAN is CSR00024598.

WHEREAS The Department of Higher & Technical Education, Nagaland is the Nodal body which takes care of courses and curriculum in various Govt. Colleges and Govt. Polytechnics in the state of Nagaland which covers Diploma and Graduation Degrees like BA/B.COM/B.Sc.

AND WHEREAS, SGBS Unnati Foundation is a registered not for profit Company, registered U/S 25 of the Companies Act, 1956, was started in 2011 as a Vocational Training Centre, engaged in Charitable activities and through its program named "UNXT by Unnati", provides training and placement assistance to final year students by way of providing a finishing school program consisting of communication skills, life-skills and assured employment in reputed organizations to the UNXT certified candidates after they have completed their graduation. The CSR registration number of SGBS Unnati Foundation is CSR00001571.

SGBS Unnati Foundation expressed its intention to conduct UNXT for 3000 students in Nagaland, under various streams over the period of one year. This shall be a **Non-financial** agreement.

**NOW THEREFORE,** in consideration of the mutual covenants and agreements herein contained, the parties hereto agree as follows:

This MOU is being entered to clearly identify the roles and responsibilities of each party as under:

### 1. Roles:

# DHTE shall perform the following responsibilities:

- DHTE shall provide Unnati with the list of colleges with address, SPOC (Single Point of Contact), number of students studying in the final year of college and the possible timings.
- ii. The classes shall be voluntary but the department must emphasis on the students to take up the course.
- iii. The colleges shall facilitate orientation programme for the students.
- iv. SPOC shall coordinate with the team ensuring that batches are provided in regular intervals accommodating timing issues or any other issues with the college authorities.
- v. DHTE shall provide infrastructure like classroom, TV or projector and internet facilities for the training programme.

## SGBS Unnati Foundation agrees:

i. The Foundation shall conduct a 30 days program - 3 hours daily, having2 batches in a day. The programme shall be conducted by a trainer. The

- hours shall be continuous and daily for the batch, except on declared holidays and Sundays.
- ii. The Foundation shall cover all Government Colleges once during an academic year.
- iii. Each batch shall have a minimum of 30 students and a maximum of 40 students in each batch.
- iv. Every trainer of Unnati shall be from the local area, trained by the foundation in Bangalore and shall be paid by the Unnati.
- v. Unnati expected target to impart training in a year shall be 3000 students.
- vi. Unnati shall hire/engaged around 10 to 12 staff/trainer across Nagaland basing on the locations of the colleges.
- vii. Unnati shall use the infrastructure of the college to deliver the classes/training.

# Investment and Development Authority of Nagaland (CSR) agrees:

- IDAN shall be the liaison organization between DHTE and SGBS Unnati Foundation.
- ii. IDAN shall publicize about the course across Nagaland through their publicity wing so that deserving students could read the benefit of the program.
- IDAN shall spread the word among the Industry Bodies to facilitate local placements.

### 2. Timeline:

SGBS Unnati Foundation & DHTE are planning to start the program by 15<sup>th</sup> of January 2023.

#### 3. MOU Timeline:

This MOU shall be valid for a period of 2 (two years) initially and which can be further extended with mutual consent of the parties.

#### 4. CONFIDENTIALITY

Each Party shall keep the Confidential Information (as defined hereinafter) confidential and shall not reveal to any third party without the prior written consent of the other Party. Each party shall ensure that its directors, officers, managers, employees, affiliates, legal, financial and professional advisors and bankers to whom the Confidential Information is made available shall keep it confidential and do not reveal to third party.

### "Confidential Information" means:

- (a) Any information concerning the organization, business, intellectual property, technology, trade secrets, know-how, finance, transactions or affairs (whether conveyed in written, oral, electronic or in any other form and whether such information is furnished before, on or after the date of execution of this MOU);
- (b) Any information whatsoever concerning or relating to this MOU; and
- (c) Any information or materials that contain or are generated from Confidential Information.

Sub: Information and Instructions for the implementation of UNXT Programme under CSR Initiative of SGBS UNNATI Foundation.

Sir/Madam,

In reference to the above cited subject, I am to inform you that, the Department of Higher Education and Investment & Development Authority of Nagaland (IDAN) had exchanged an MOU with SGBS UNNATI Foundation on the 12<sup>th</sup> January 2023 in the presence of the Chief Secretary to the Government of Nagaland for implementation of UNXT Program under CSR Initiative of SGBS UNNATI Foundation in Government Colleges under the Department of Higher Education.

For the successful implementation of the UNXT programme and taking into consideration of the local conditions, IDAN had convened a joint meeting of officers from IDAN, Directorate of Higher Education and the 10 Change Makers on the 1<sup>st</sup> February 2023 and resolved the following points:

- Initially the UNXT programme shall be implemented in the following 7 (seven) selected Government Colleges under UNXT Programme Phase 1 –
  - (i). Kohima Science College (Autonomous) Jotsoma (ii). Kohima College Kohima (iii) Fazl Ali College, Mokokchung (iv). Dimapur Governmentt College, Dimapur (v). Sao Chang College Tuensang (vi). Zunheboto Govt. College, Zunheboto (vii). Wangkhao Government College, Mon.
- 2. After the successful implementation of UNXT programme in the select Government colleges, the programme shall be extended to the following remaining Government Colleges under UNXT Programme Phase 2.
  - i.e- (i).Mt. Tiyi College Wokha (ii).Yingli College Longleng (iii). Zisaji Presidency College, Kiphire (iv).Phek Government College,Phek (v).Pfutsero Government College (vi).Peren Government College (vii). MCTE Yimyu, Mokokchung and (viii). SCTE Kohima.
- 3. SGBS UNNATI Foundation has already trained 10 Change Makers as trainers for UNXT programmes. The 10 Change makers have been assigned against specific colleges for implementation of the programme. The Details of the Change Maker and the college assigned to them is enclosed in ANNEXURE-1.
- 4. As per the UNXT Programme, the duration for classes shall be 3 hrs daily for a period of 1 month (for a particular batch). The Change Makers are instructed to meet the Principals

- for finalisation of class timing and also to give proper orientation to the students on the importance of UNXT Programmes.
- 5. Nominated Shri. Changsang ,Under Secretary to the Government of Nagaland Investment & Development Authority of Nagaland (IDAN) -PH.NO.8974837948 and Shri. Menuokholie Kire, Joint Director (ADMN) Directorate of Higher Education, Govt. of Nagaland -Ph.No 9485238349 as SPOCs in the two Departments for UNXT Programme.

## **Instruction to the Principals:**

- The Change Makers will be visiting their assigned colleges for finalisation of the class timing. The Principals are instructed to finalise the timing to enable the change Makers to start the UNXT Programme at the earliest.
- 2. To provide class rooms and one Smart TV.
- 3. Allow the Change Makers to organise Orientation Program for the students.
- 4. Nominate an efficient Assistant Professor/Associate Professor as SPOC for UNXT Programme for proper coordination with the Change Makers ,IDAN and Directorate of Higher Education. Send the nomination Letter to the Director Higher Education with the details such as- name/designation/contact number and email.
- 5. To extent all possible assistance to the Change Makers.
- 6. To provide transportation for the students and instruct the chowkidars or peons to be present during the class hours.
- 7. The Principals shall be the overall in-charge of the UNXT Programme.
