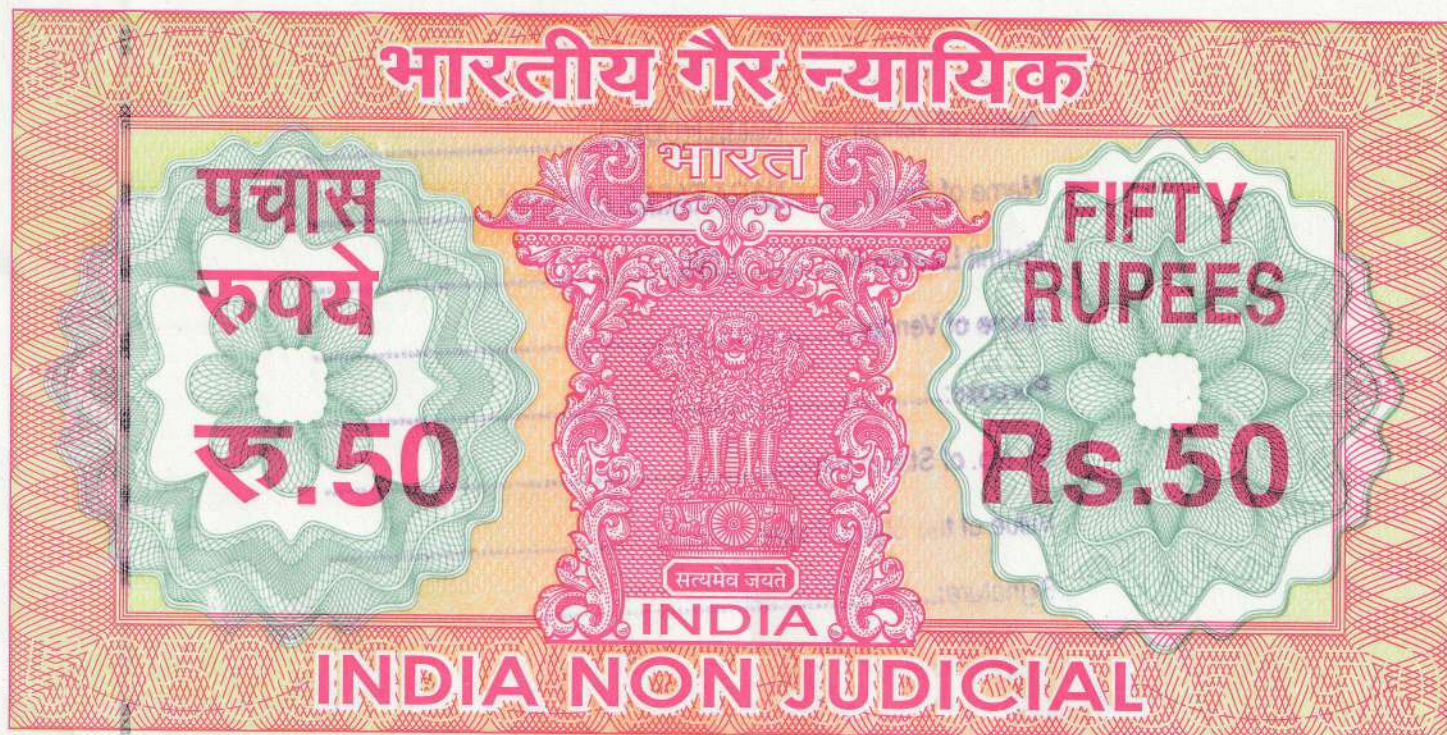

Whereas, Computer centre Tuensang headed by Mr.Santosh assisted by trained tutors shall henceforth provide technical support in training students of Sao Chang College and shall have the authority to provide Diploma Course in Computer Education under Vocational scheme facilitated by Sao Chang College.
