AND

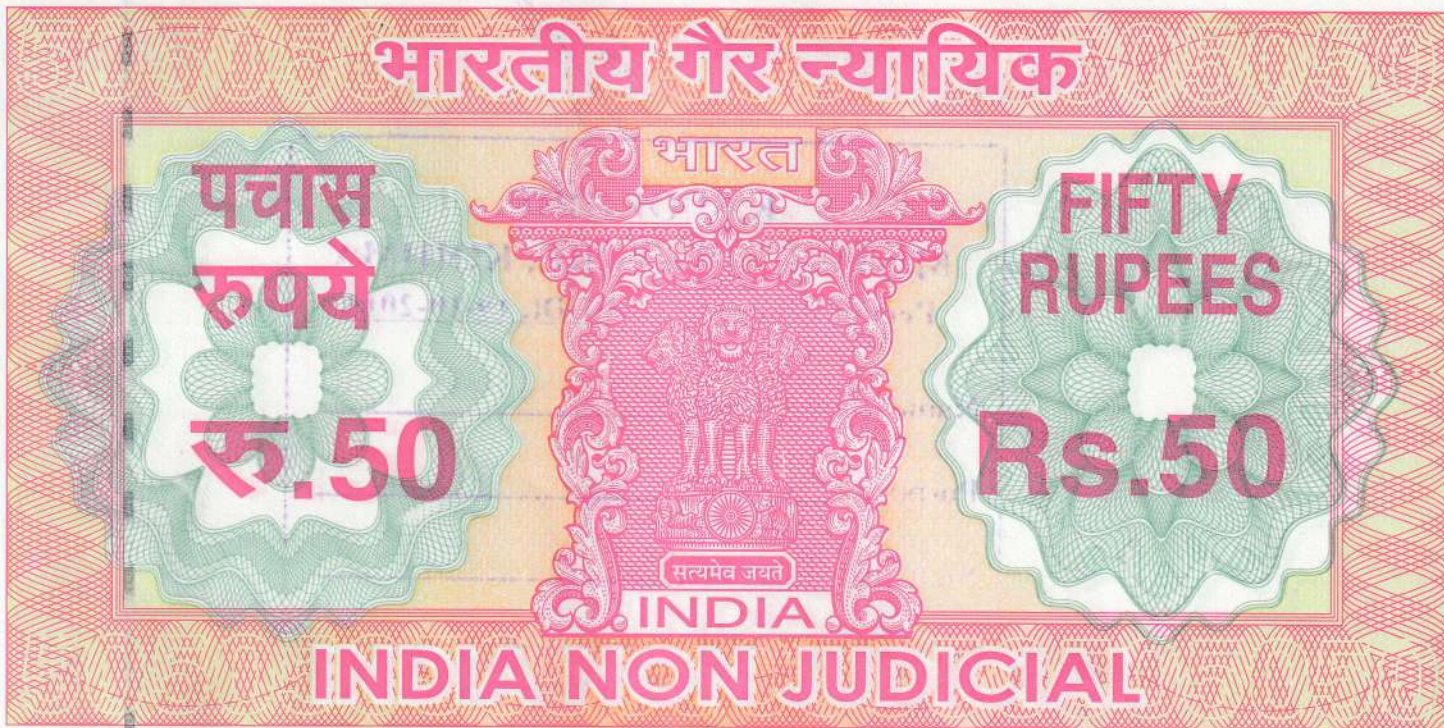
DIGITAL MORUNG TUENSANG

This agreement was signed on 19th day of April 2023

Whereas, Sao Chang College, Tuensang, is an Educational Institution established in 1973 and subsequently recognized as a Government College in the year 1983 under the Department of Higher Education, Government of Nagaland. The Institution (hereinafter referred to as SCC) is a premier secular college under Tuensang District catering to undergraduate course in both Arts and Science Stream.

Whereas, Sao Chang College, headed by the Principal Dr. Vitsosie Vupru, Vice-Principal Mr. Longtichang Tzudir and teaching faculty comprising of Associate and Assistant Professors shall be assisted by the Digital Morung, Tuensang, in imparting theoretical as well as practical computer application lessons to the students as and when need arises.

Whereas Digital Morung, Tuensang, with Shri. T. Sangmai Choba as the head of the Institution shall be assisting the college in manning the college website and shall henceforth provide technical support in enhancing the technical skills in computer education through Diploma and Certificate Course. Further, Mr. T. Sangmai Choba shall be paid an annual sum of Rs. 6000/- (Rupees six thousand only) for maintaining the

college website for a period of 3 (three) years and will be payable again as and when this agreement is extended accordingly. Students undergoing diploma course at the college shall be given 50% fee payment concession by the Digital Morung and from the remaining 50%, an amount of Rs.500 shall be remunerated by the college authority as freeship.

Reversal of the Agreement

Both the parties are sanctioned to have review and reflection concerning the implementation of the programme as and when the need arises, the parties can have joint meeting to discuss and evaluate the status and achievement of the programme. All reports concerning the status and progress of the programme shall be updated periodically.

Duration and Termination of the Agreement

This agreement shall be effective from the date of signing and shall remain in force for a period of 3 (three) years. It shall automatically be renewed for the next three years & unless discontinued by either party.

Settlement of Disputes

The Parties shall use their best efforts to settle amicably all disputes arising out or in connection with this contract or its interpretation.
