Sao Chang College, Tuensang, a higher education institution established in 1973 and subsequently recognized as a Government College in the year 1983 under the Department of Higher Education, Government of Nagaland, and the Institution (hereinafter referred to as SCC) is a premier secular college under Tuensang District catering to undergraduate course in both Arts and Science stream headed by the Principal Dr.Lanurenla as the authorized signatory

And

Better Life Foundation (BLF), a registered Society, registered in the office of the Registrar of Societies, Home Department, Nagaland, under Societies Registration Act, 1860 and amended vide Societies Registration (Nagaland First Amendment) Act, 1969, and bearing registration NO.HOME/SRC-6284, Dated:12/05/2009 and having its registered office at Sangtamtilla Village in the district of Dimapur, acting through Ms. Kumjunglila Sangtam, Secretary BLF, the authorized signatory.

Whereas, the Memorandum of Understanding (MoU) aims to establish a collaborative partnership for educating students on forest and biodiversity, and waste management to undertake awareness and action at college and community level while developing solutions enabling the creation of a sustainable environment and to conduct various projects, seminars and workshops related to environment and forestry on conservation of natural resources, capacity building, sustainable livelihood, experience sharing and training for promoting eco-friendly environment.

Whereas, under the MoU, the college will assist in activities taken up by the Better Life Foundation (BLF) for promotion and creating awareness among students about the initiatives of BLF while also motivate students to undergo various campaign and training program organized by BLF and promotion of environment friendly products.

Whereas, through this collaboration, the SCC and BLF will contribute towards utilization of natural resources for sustainable development. Realizing strength of both the institutions, there will be exchange of experience and scientific knowledge, working on their mutual progress and for service of the society, in the field of science & technology, environment and climate change, resource utilization and to boost livelihood security along commitment to work together in achieving the goals outlined.

Reversal and Review of this Agreement

Both the parties are sanctioned to have review and reflection concerning the implementation of the programs as and when the need arises, the parties can have joint meeting to discuss and evaluate the status and achievement of the Agreement concurred upon. All reports concerning the status and progress of the Agreement shall be updated periodically.

Duration and Termination of this Agreement

MoU shall be effective from the date of signing and shall remain in force for a period of 3 (three) years. It shall automatically be renewed for next three years until & unless discontinued by either party who shall notify in writing, of its intention to terminate the MoU, at least (3) three months before the expiry date of the relevance period.

Settlement of Disputes

Any dispute or differences arising at any time between the parties hereto emerging out of or in connection with the two in relation to Agreement shall be referred to and settled amicably between the parties.
