"Anti-ragging and sexual harassment- prevention, prohibition and redressal" programme conducted

A one day seminar on the topic "Anti-ragging and sexual harassment- prevention, prohibition and rehearsal" was organised in the College on 9th November 2021. The programme was organised by the IQAC and Anti-Ragging & Internal Compliance Committee in collaboration with the Tuensang District Legal Services Authority. During the seminar, Advocate Mr. Soted Anar from the TDLISA highlighted the various legal provisions available under the Indian Penal Code (IPC) against ragging and bullying in work places, institutions and in any place in the society. TDLISA Advocate Ms. Antimangyang Chang also spoke on the sexual harassment (prevention, prohibition and redressal) Act 2013 a legislative Act of India. Mr. Kudilong Kessen from Judicial Magistrate Tuensang also spoke on various Cr. PC sections available legally for dealing with different cases in India. The programme was chaired by Mr. Akyuba Sangtam, Assistant Professor, Mr. Longtichang Tzudir, Principal In-charge welcomed the participants and vote of thanks was proposed by Dr. Santosh Kumar Singh, Co-ordinator, IQAC. 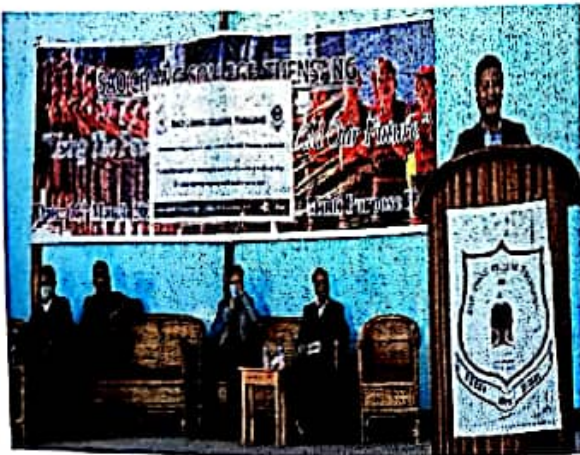

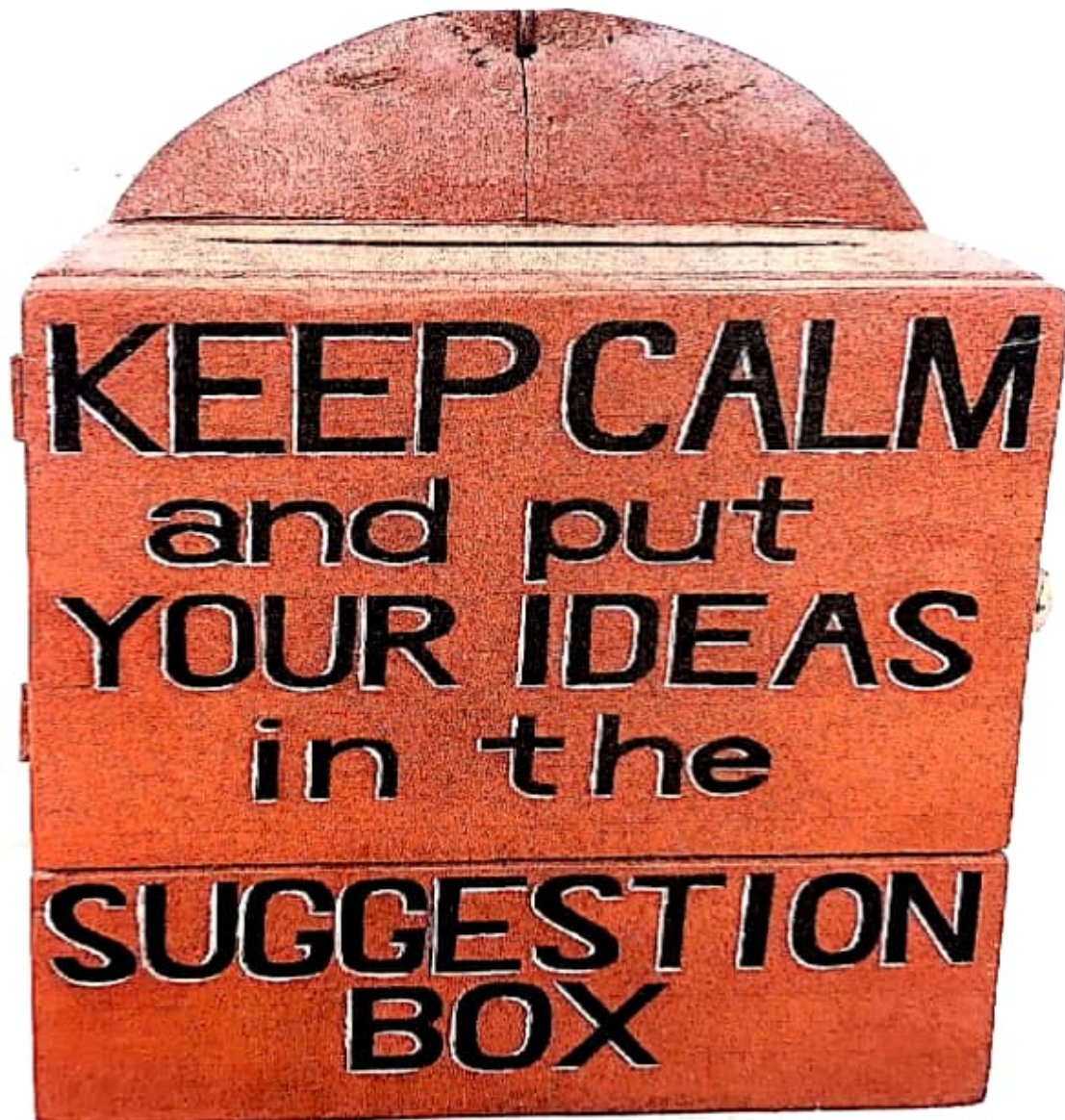
